

## Contest rules: "Summer Contest"

### Article 1: Name

BGL BNP Paribas S.A., established and having its registered office at 50 avenue J.F. Kennedy, L-2951 Luxembourg, registered in the Luxembourg Trade Register under number B6481, is organizing a contest hereinafter referred to as "Summer Contest 2025".

#### Article 2: Duration

The free contest will be open from June 26, 2025, and will end on July 10, 2025, included. The draw will take place on July 28, 2025.

#### Article 3: Participation and progress of the contest

The simple fact of taking part in this contest implies acceptance of these rules, which have contractual value.

The game is open to any natural person aged 18 or over and with full legal capacity, provided that they tick the "I have read and accept the conditions of the Summer Contest 2025 contest" acceptance box on the Microsoft form.

Access to the contest is forbidden to employees of the BNP Paribas Group marketing department in Luxembourg and their direct family members. Only one entry per person will be accepted during the contest period. Participation is nominative and unipersonal.

Failure to comply with the conditions of participation set out in the rules will invalidate participation.

## Article 4: Modification

BGL BNP Paribas S.A. reserves the right, at any time and without prior notice, to extend, suspend or interrupt the contest described in Article 1. BNP Paribas S.A. shall not be held liable by the participant or any other person.

#### Article 5: Liability

In the event of cancellation of the contest by BGL BNP Paribas S.A., the latter may under no circumstances be held liable for the consequences of this decision.

Nor shall BGL BNP Paribas S.A. be held liable for any technical problems whatsoever.

### Article 6: Principle of the contest

The contest is offered on a one-off and temporary basis from June 26, 2025 to July 10, 2025 included, with the aim of winning the prizes listed in article 7.

3 winners will be drawn at random from among the participants. Each of the 3 winners will be awarded the prize mentioned in article 7 according to the draw. BGL BNP Paribas S.A. undertakes not to publish the names of the winners without their prior written consent.

### Article 7: Prize

The winners will be offered one of three electric scooters. The prize awarded may not be contested in any way whatsoever, nor may its equivalent value be given in any other form whatsoever, nor may it be replaced or exchanged for any reason whatsoever.
